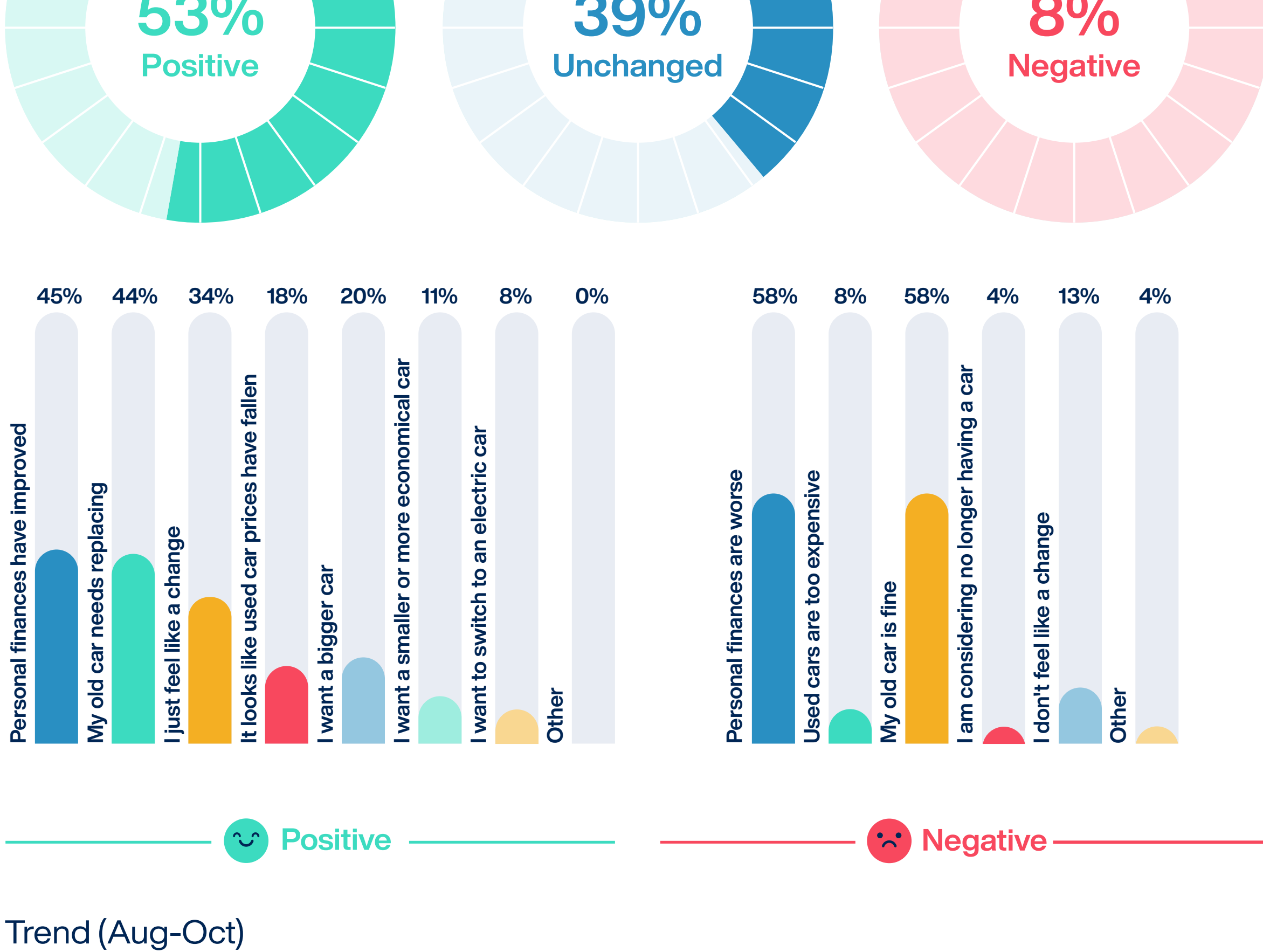

Q1 > How do you feel about the idea of buying a used car this month?

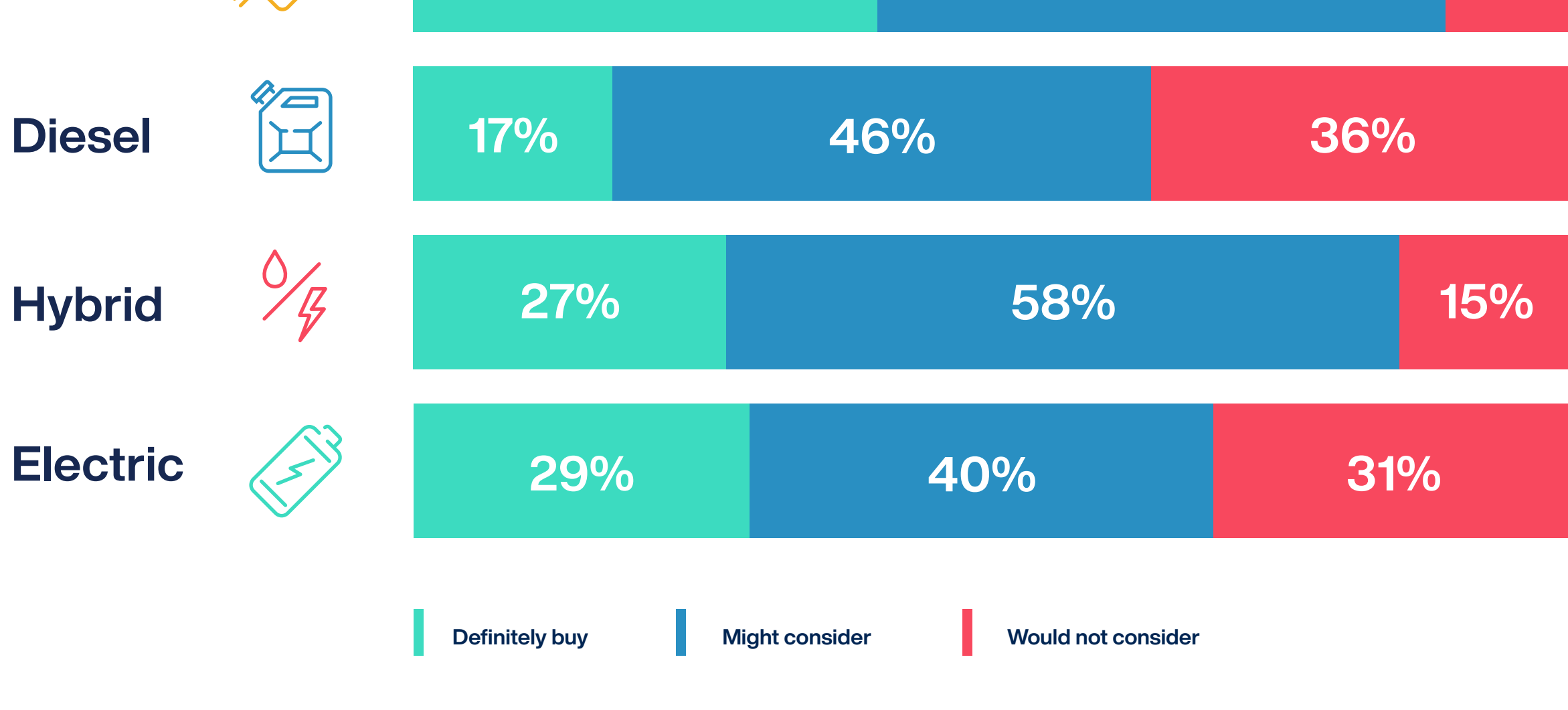

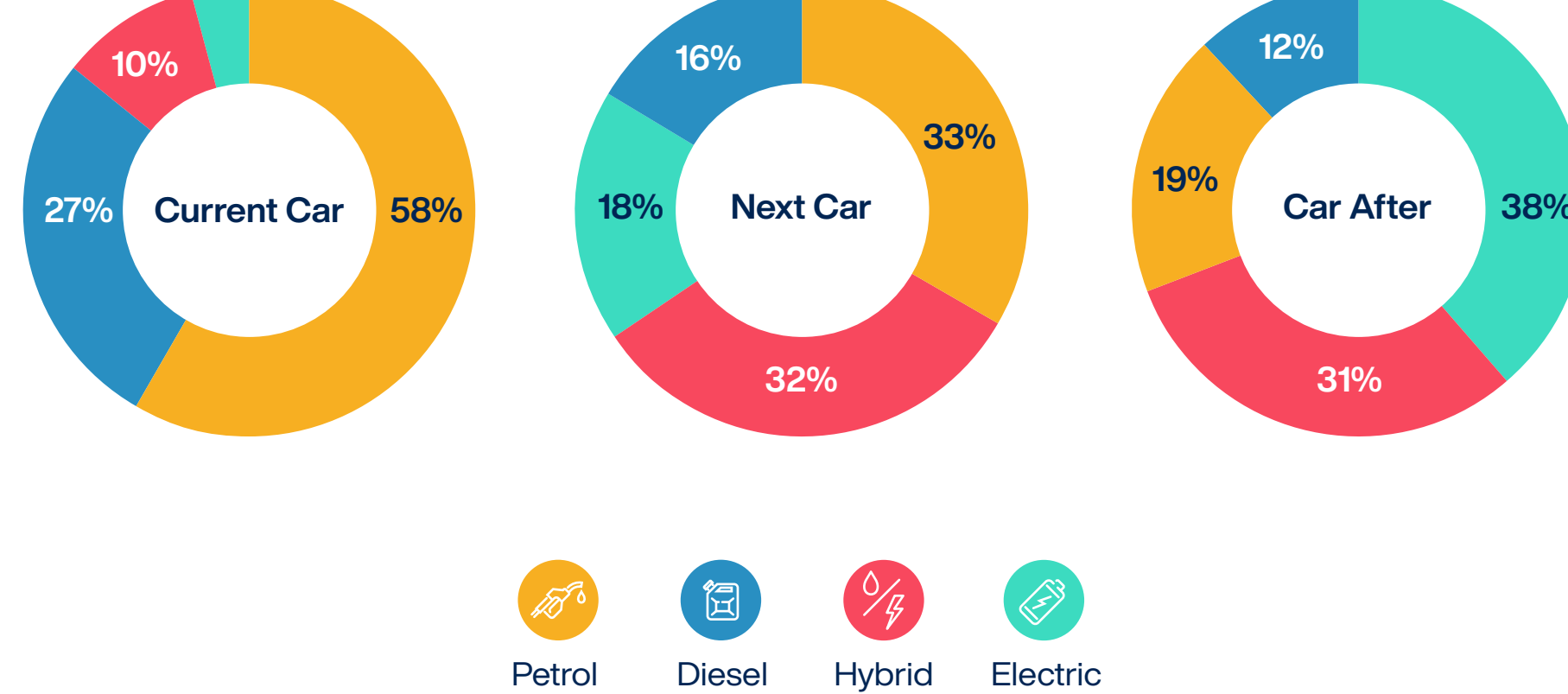

What is/will be the fuel type of your ...

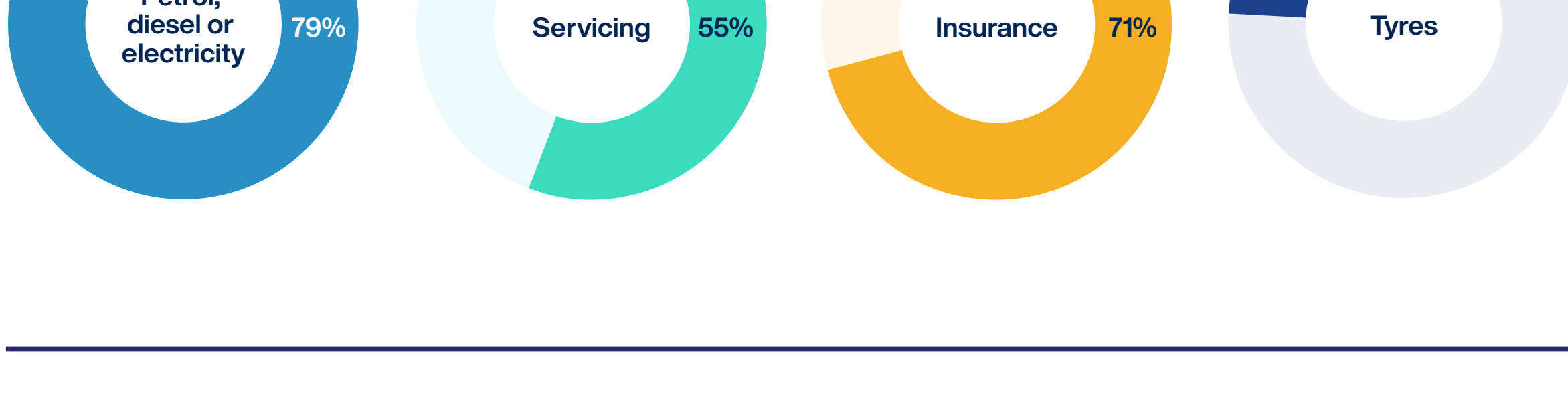

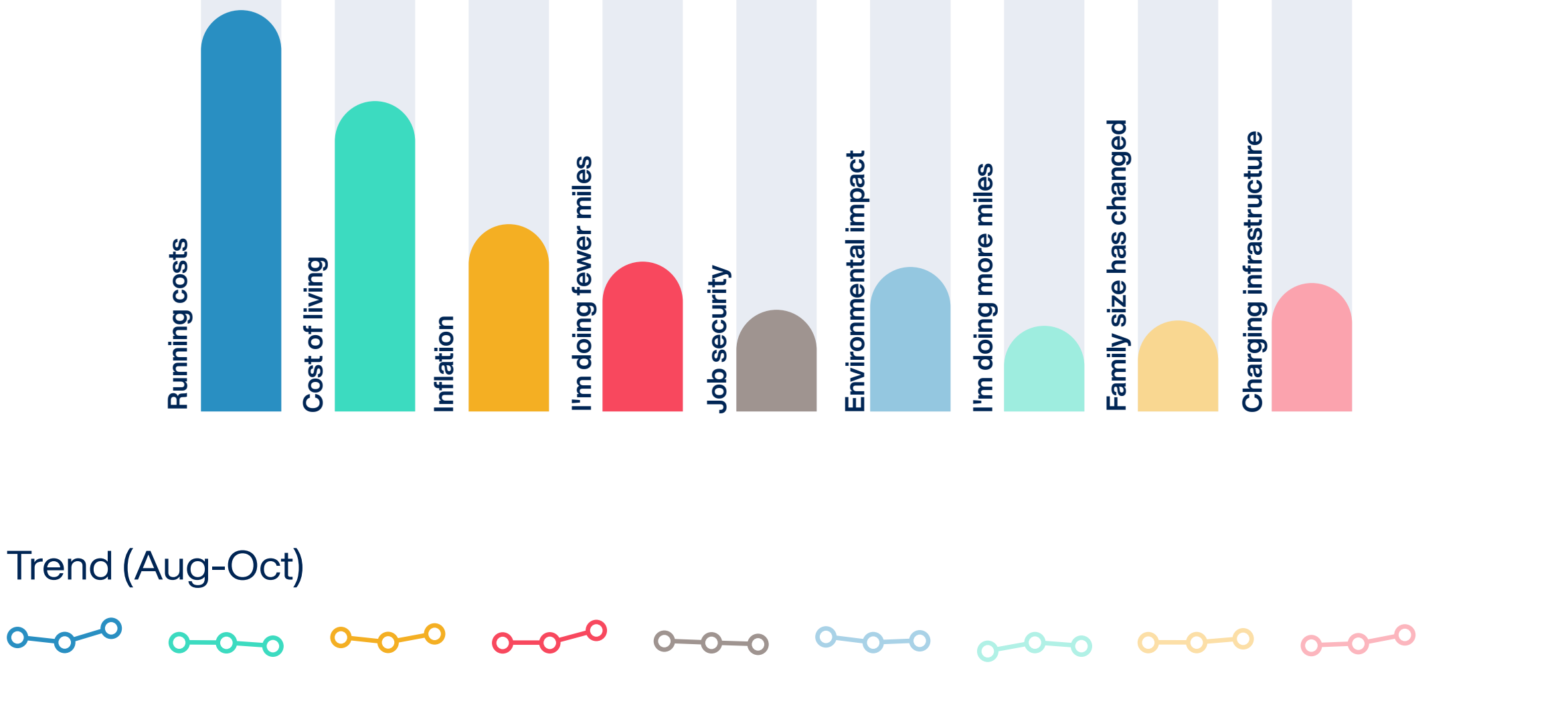

Q4 > Which of these factors would influence your choice of car? (choose as many as apply)

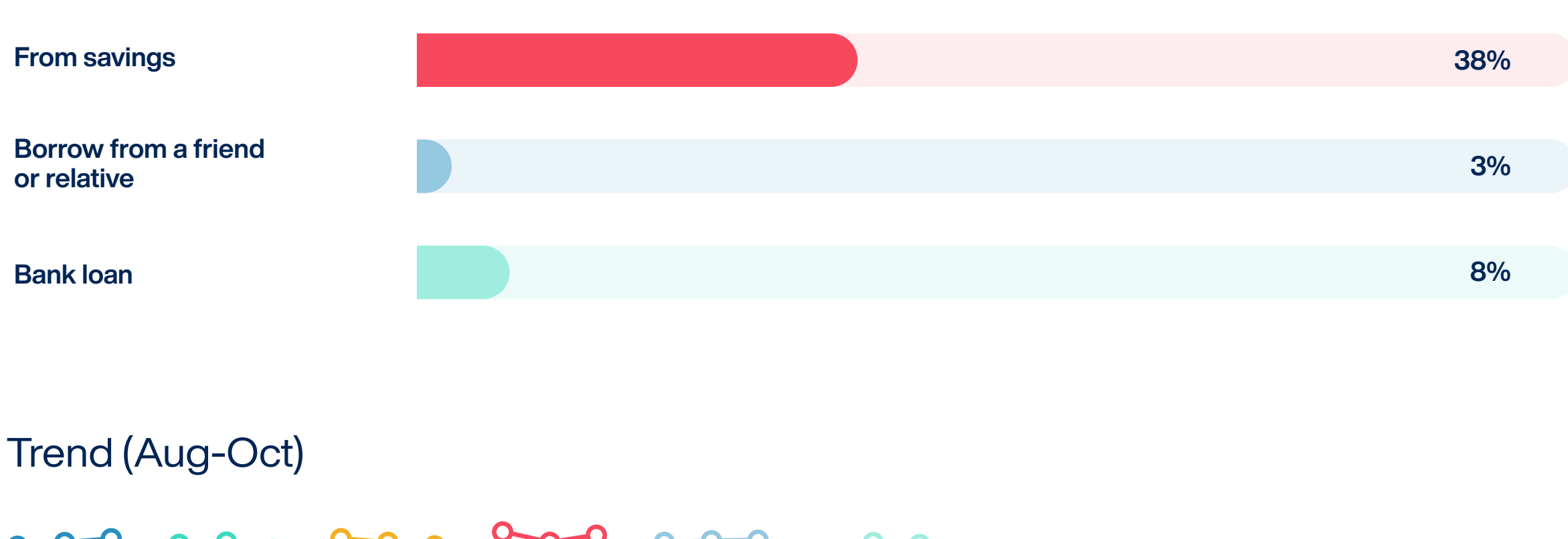

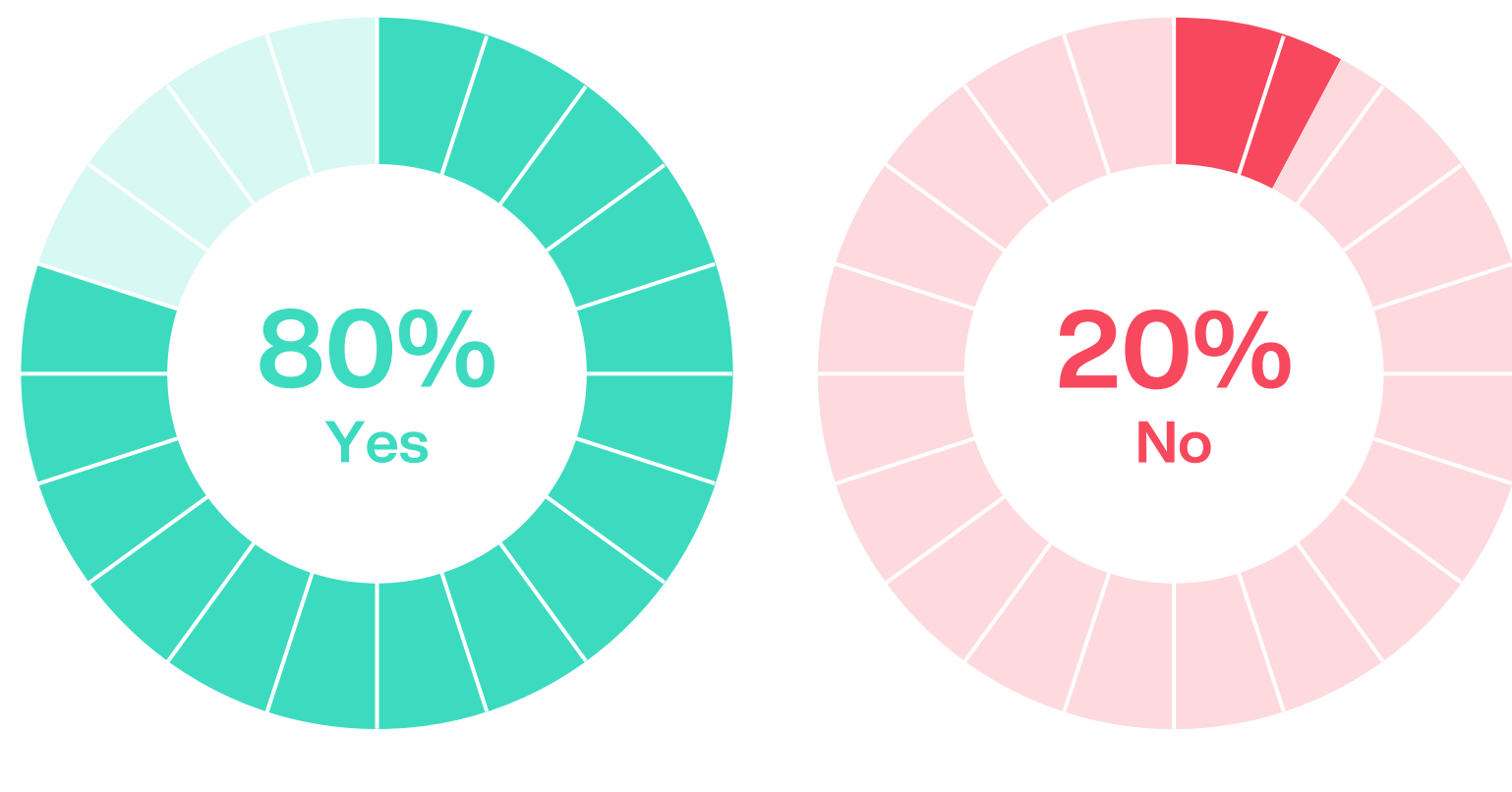


Topical Questions
